#### E. New Business:

- 1. Safety and Security Presentation: Several CPS staff members presented components of CPS's comprehensive safety and security measures. Some components discussed were: facilities' security measures, bus safety, digital security, student safety & social/emotional, and behavioral health, attendance, threat assessments, and discipline trends regarding suspensions. Members of CHS, GMS and Elementary spoke about building based security and safety. Staff shared CPS guiding principles that *staff* understand, believe deeply and are accountable for the safety and security of every student and staff member, and for the social emotional and behavioral growth for every child. Members offered feedback to presenters and asked questions. Members liked where CPS fell with regard to absenteeism and suspensions compared to our neighboring towns. A discussion about the GMS strategies room clarified that even though the classroom is not open all blocks, students still have access to guidance staff or office staff if needed. There was discussion about how CPS notifies parents regarding repeated absences; staff confirmed that all information about absences is in the student handbook and is mandated by pupil absence notification laws. All schools' safety infrastructures are not exact, but very close; CPS continues to work on updating infrastructures.
- 2. CHS Program of Studies: Mr. Derek Folan and Dr. Meredith Chamberland review the 2020-2021 Program of Studies. The entire copy of the Program of Studies is available on the website under the School Committee Tab/Meetings, Agendas and Minutes/Reports. The green highlighted sections indicate additions/revisions that were designed to meet the various needs of CHS students. There are minor changes in several departments with regard to Honors and CP offerings, Mandarin is no longer offered as a World Language, and there are some minor revisions to course descriptions and curriculum.
