E. <u>Teaching and Learning Report</u>: Ms. Heidi Olson provided an overview of the World Language Department programs in the District. MA Frameworks were reviewed. The MA Seal of Biliteracy is an initiative that Canton is in the second year of doing. Students are recognized for being bi-literate. Ms. Olson applied for and received 2 grants this year. Language activities and offerings at each level were shared, including summer offerings. Ms. Arboleda and Ms. Moran expressed the importance of

  Lourenco shared highlights and fundraising efforts of this school year. The operational costs
  of fundraisers, i.e. police detail, building rentals, and custodial costs are being discussed with
  the District so a funding plan can be outlined for future events. They thanked individual
  members for their contributions and discussed current and anticipated openings for volunteer
  posts.
- 2. JFK School Spotlight and JFK CAPT Spotlight/Honors: Principal DiDonna and Team Chair Administrator, Kate Gallahue shared school highlights and honored the work of the school support groups. Discussion ensued about building-based collaboration teams, Instructional Models, and how data is used to adjust instruction. Other Professional Development and Collaboration efforts were discussed. Extracurricular and other fundraising activities were shared.

 School Year Calendars: Superintendent Folan presented the 2022-2023 school calendar for a 1st read. The proposed first day of school for staff is August 29, 2022, and the 1st day of school for grades 1-12 would be Wednesday, August 31, no school on Friday, Sept. 2 for a long weekend. Sept. 6 would be the Kindergarten start date and Sept. 7 would be the PreK start date. After reviewing the Early release survey results and data analysis, Friday is the preferred choice for early release day. An updated 2021-2022 school year calendar was shared noting Tuesday, June 21, 2022, as the last day of school.

- 3. COVID-19 Update: Superintendent Folan provided updated vaccination rates. CHS at 81%.
- 4. <u>Assistant Superintendent Contract</u>: Chair Merenda shared the terms of Assistant Superintendent Shannon's contract. Terms include 2 years, beginning July 1, 2022. \$163,343 for year 1 with a 2% increase in year 2, \$166,610. Tuition reimbursement for grad school, and total reimbursement not to exceed \$10,000, with the Superintendent's approval.
