

DPH COVID-19 Dashboard



Change Made:

• Shortened the time to remain temperature free from 72 hours to 24 hours within the 10 day isolation

Health and Safety

Changes Not Made and Rationale:

- Whole cohorts identified as close contacts
 - o In consultation with the Canton Health Department about "contact tracing" this is the most conservative identification of close contact in order to broadly protect staff and students who have been exposed
- Providing different waiting rooms for symptomatic individuals
 - We will provide surgical masks for the students and we will keep them 6' apart in the room. Both Dr. Muse and the Canton Health Department are in agreement with this process.


Transportation Update

- Bus transportation provided beginning September 21st for grade
 K, 6 & 9
- Bus routes published in Canton Citizen and on District website on Thursday, September 17th
- Bus passes distributed by email (temporary) before start of school
- Permanent bus passes distributed at schools after reopening

Transportation Plan

- Students will be seated no more than one student per bench, alternating sides for each row, which allows students to maintain approximately 3 feet of physical distance. Children from the same household may sit together and in closer proximity (e.g., two students per bench)
- <u>All</u> staff and students on the bus, regardless of age, are required to wear masks at all times.
- Students will be assigned to a single bus and a particular seat
- The district is considering adding a bus monitor for every bus to ensure strict adherence to health and safety guidelines
- School schedules may add tier to bus plan and increase transportation costs
